

## **ASI RV & Camping Rules & Regulations (January 2012)**

1. The Air Sailing RV & Tent Camping area is for the sole use of glider pilots, crew, family and Gliderport-related activity. We reserve the right to request that any RV or tent not meeting the intent of the site be removed or will be removed at the owner's expense.
2. Self-contained motor-homes, fifth-wheels, travel trailers and tents only please. Please park in designated areas. We provide **NO** electrical, gray water or sewage hookups. Gray water **MAY NOT** be drained at the camp site.
3. Please **do not run extension cords** from clubhouse or bathhouse except for **temporary** use (e.g. cleaning) or battery recharge. Extension cords may be unplugged by Airport Management at anytime as required for facility operations. This is primitive camping at its best.
4. All campers must register at the Clubhouse upon arrival. Please sign the guest log with arrival & departure dates and indicate the site number you have selected. This log is required to substantiate your compliance with the 60-day rule.
5. This is an active airport with associated hazards. **Please read the ASI Operating Rules and Policies available in the clubhouse for more information on glider-port operations and safety.**
6. Per county regulations, the maximum continuous stay at our facility is **60-days**.
7. Maximum occupancy per site: 6 persons.
8. Speed limit of 5 miles-per-hour will be enforced within the entire gliderport & camping area.
9. Only two pets are allowed per site. All pets must be under control of their owners at all times and messes must be cleaned up by their owners. Animals are the exclusive responsibility of their owners. Disruptive pets will not be allowed.
10. Laundry facilities are available 24-hours daily. If you choose to use your own clothesline, do not tie it to the trees, and remove it when you leave
11. **Quiet hours are from 10 pm. until 9 am.** No portable generator operations during this period. Please think of your neighbors.
12. A two-car maximum is allowed per site. Only holders of a valid driver's license are permitted to operate a vehicle of any kind. See the ASI Operating Rules for use of golf carts.
13. Valuable objects should be stored away. We are not responsible for personal property.
14. No open campfires will be allowed. Propane grills and picnic tables are provided at the gazebo near the clubhouse. These facilities are shared; please use them only at the gazebo.
15. Do not throw garbage in bathhouse containers. Do not throw anything except tissue provided into the toilets. Turn off lights and fans when leaving the bathhouses (we make our own electricity!). Please keep the Clubhouse and Bathhouse doors closed (keeps rattlesnakes out!).
16. The Clubhouse is a shared facility provided for ASI guests. The kitchen sink and dry rack is for your use, but please store all your items back at your campsite. There is very limited space in the refrigerator which may be shared by all visitors but please remove all your items at the end of your stay. The refrigerator may be cleaned on short notice. Please label and date your items. We reserve the right to throw away any item in the refrigerator at any time.
17. Garbage must be placed within the trash containers provided. Recyclable items should be sorted into containers provided. Please pick up any trash you see and help keep our glider-port clean.
18. No discharge of firearms or fireworks will be allowed.
19. Rules and regulations may be changed at any time without prior notice
